2. Click on "F-1 Student Services" and then "Request for a Final Semester Reduced Course Load". Complete the entire E-form and upload a copy of this form (pages 1 and 2; saved as a PDF or JPEG). Both the student and the academic advisor must sign the form.

REMEMBER: Do not drop or resign below full-time until ISS approves the Reduced Course Load request. ISS will make a decision on the request (approve or deny), and will notify the student of our decision via email within 5-7 business days of submission.

Once approved by ISS, this Reduced Course Load cannot be canceled.
